Terms and Conditions
for payment of your annual subscription by
standing order

Whittaker Golf Club will on receiving your 1st payment by Standing Order, implement the following terms and conditions:-

- Payments are due from the 1st January to 31st December in the season selected for payment by standing order. Interest will be charged on payments made by standing order.
- Any payment not made on the due date (for any reason) will result in the full payment of the balance of subs becoming immediately due (Including Interest). In this instance individuals are not current members of the club and as such cannot enter competitions and must pay full visitors green fees if they wish to play the course.
- Where a member resigns during a season his standing order payments are still due to continue for the full period up to 31st December. Any refunds are at the sole discretion of the committee.
- In the case of members joining after the start of the season any request to make payment by monthly instalments will have to be decided by the Treasurer on an individual basis.
- Only the clubs own printed standing order forms can be accepted from members wishing to pay by standing order.
- In every case the completed bank standing orders must be returned to The Hon Treasurer within 10 days after the date of the relevant Annual General Meeting. Members are therefore requested to obtain the blank standing order forms from the Club well in advance so as not to miss the due starting date for payments.
- Junior subscriptions cannot be paid by standing order but all other membership categories may pay by monthly standing order.
- The committee reserve the right to reject acceptance of a person's application to pay by monthly standing order if they feel there is just cause for such a refusal.
- These Terms and Conditions will remain in force while you pay your subscriptions on a monthly basis.
